DID YOU KNOW?

Medical Subsidy can help pay for tutoring or camp!

Families can use a subsidy for tutoring up to \$150 per week. This benefit is available for children who attend public schools, private schools or are homeschooled. The request for this benefit must include a written recommendation for tutoring from the child's teacher(s), an estimated length of time, a written plan or syllabus, and documentation verifying that the tutor is qualified.



Medical Subsidies can also help pay for camp up to \$500 per calendar year. The camp must be licensed in the state where it is located. Documentation from the child's professional service providers is needed to verify that camp would benefit the child.

The prior approval requests should be mailed to the AGAO Medical Subsidy office. Additional verification may be required.

Dave was an American businessman, philanthropist, fast-food tycoon and founder of Wendy's. He was adopted between six weeks and six months old. As an adult, he became a well-known advocate for adoption. He founded the Dave Thomas Foundation for Adoption, which is a nonprofit public charity dedicated to finding permanent homes for children waiting in foster care in the United States and Canada. He also became an education advocate and founded the Dave Thomas Education Center, which offers GED classes to young adults.
